



DRIFT JUDGE TRAINING AND EVALUATION HANDBOOK

Welcome

Welcome to drift judge training and evaluation. Within the framework, the applicant will learn the principles, philosophy and critical thinking of drifting. The training lasts approx. 10 hours. After the training there will be examination and the successful applicants will receive Certification by the Hellenic Motorsport Federation (OMAΕ), as responsible for the drift races in Greece. Learning the principles of the sport from prospective examiners are prerequisites for effective dissemination of sports principles through the approved procedures.

About education

Definition

A car is drifting by selecting the fastest flow through the racing line, absolutely controlled and seeking the sight of weight transfer, “tandem” runs and controlled drifting combined with objective criteria, such as speed, angle and distance. The judge should be able to determine the desired skills by each athlete in a sport that critical thinking is essential. When you have understood the principles of the sport, you will be assessed capable in judging drift races.

Principles

Drifting is a kind of motorsport, seeking spectacular and safe driving in controlled and safe conditions. As a controlled way of driving RWD vehicles, it is the fastest way to drive on reduced traction surfaces such as driving on ice and snow. Driving on tarmac on tires with controlled or reduced traction, a spectacular driving style is achieved for both the driver and also for lovers of the sport.

This way of driving becomes a formal sport that competes on major racing circuits and many athletes seek their participation, both for the experience and also for improving their drifting skills through proper evaluation by competent judges.

Education Details

The purpose of education is:

- 1) Analysis of the philosophy, principles and objectives of skidding as a motorsport
- 2) Critical thinking about the sport and its evaluation

On successful completion of training, successful candidates will be able to:

- 1) Rate a race, according to the recognized standards
- 2) Analyse a passage and keep notes
- 3) Mark the signs of improvement to a driver
- 4) Use the Code of Conduct

Appraisal

The evaluation will be theoretical and practical. Beyond the curriculum it is essential to know the National General Drift Regulation. The theoretical part includes the questionnaire in the curriculum and the general regulation. Also, the ability of the person to analyze critically and also the ability to judge single and twin drifting runs on video will be tested.



Passing the evaluation

The trainee assessor must assess overall by over 60% in each evaluation criterion for considering success. If you scored between 40-60% overall, is given the opportunity to assess without the need to attend the training again, and if it takes less than 40% in the assessment, then it is obliged to attend again the education.

Evaluation criteria

1. Adequate knowledge of general grading regulations (30%)
2. Adequate knowledge of general regulation of drift races (20%)
3. Proper use and completion of recognized standardized results (15%)
4. Description and scoring analysis ability (35%)

Type of evaluation

This is an evaluation that emphasizes both the piece of theoretical knowledge about the rules of drifting, and also their practical application in the real race. Equally important is the correct wording and the proper completion of formal standards results from learners.
